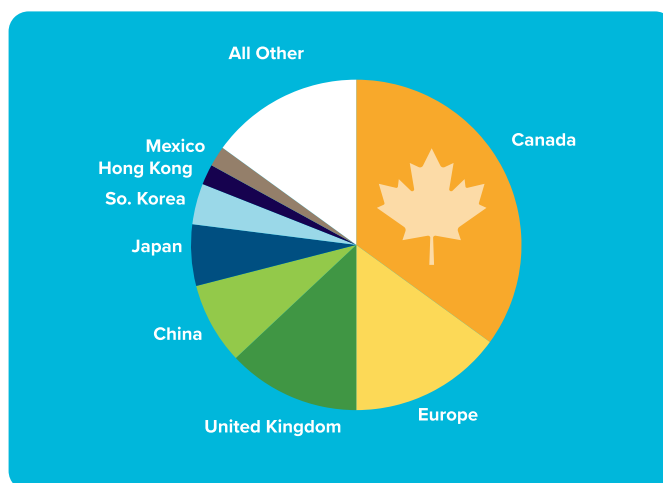




FOR THE FIRST TIME IN HISTORY: A U.S. WINE TRADE DEFICIT WITH CANADA

American wineries caught in the crossfire of a trade dispute they didn't start

On March 4, 2025, U.S. wine and other alcoholic beverages were hit with both provincial and federal retaliation in response to President Trump's IEEPA tariffs¹. Overnight, American wines were removed from store shelves and replaced with "Buy Canadian" signs or wine from global competitors.



A HISTORIC RECORD BROKEN

- A decades-long trade surplus flipped to a trade deficit² — the **most significant market disruption in decades**.
- There has been no comparable, immediate drop in wine sales of this magnitude in recent history.
- U.S. wine producers — **approximately 95% of which are family-operated**, small and mid-sized wineries — are collateral damage in a trade dispute that has nothing to do with them.

CANADA: #1 U.S. WINE EXPORT MARKET

- In 2024, Canada accounted for **36% of U.S. wine exports**, representing **\$459.5 million³ in shipments** and **CAD\$1.1 billion in retail sales⁴**.
- In 2024, exports to Canada were larger than the next three markets combined — EU, UK and China.
- Ontario, Quebec and British Columbia sell the most U.S. wine — yet only Alberta and Saskatchewan allow the importation and sale of U.S. wine.
- If the bans persist, the U.S. will cede its share of the market to the EU, Australia and New Zealand.

HARM TO BOTH SIDES OF THE BORDER

- U.S. and Canadian jobs are at risk, including U.S. vintners, Canadian sales reps and importers.
- U.S. wine producers have **lost an estimated \$196 million in export value** to Canada since March 2025⁷.
- The Canadian federal government is estimated to have **lost CAD\$20 million in tax revenue**, and provinces collectively lost **CAD\$86 million in provincial tax revenue** from lost U.S. table wine sales⁸.

OTHER MARKETS CAN'T PICK UP THE SLACK

- Total U.S. wine market volume **declined 4% in 2024** and remains a highly competitive market⁵.
- State-by-state distribution laws limit expansion.
- National labeling rules make Canadian-labeled wine **unsellable without costly relabeling**.
- 2025 **U.S. wine exports are down 30%**, with key export markets in decline due in part to consumer backlash against U.S. products⁶.

- The U.S. is the **4th-largest wine producing country** in the world after France, Italy and Spain.
- Wine is produced in all 50 states and **generates more than \$325 billion in total economic activity** from production, distribution, sales and consumption⁹.
